**Sub: Complaint to Register an FIR against Mr. Saleem Baig & Others
under Pakistan Penal Code and other enabling laws**

This is an official complaint and request for investigation on behalf of M/s Labbaik (Pvt) Ltd (hereinafter referred to as the "**Complainant**"), filed through its authorized representative Azhar Shamim son of Zafar Ahsan (hereinafter referred to as the "**authorized agent**") against Mr. Saleem Baig, Muhammad Farooq, Muhammad Ikram Barkar, Mr. Sheeraz Asghar, Mr. Asim, Mr. Amin Bhatti, Mr. Mazhar Chauhan and others on the following fact and grounds:

1. M/s Labbaik (Pvt) Ltd (the Complainant") is a private limited entity registered with the Securities & Exchange Commission of Pakistan under the laws of the Islamic Republic of Pakistan and involved in the business of Satellite Television and Broadcasting. The Complainant is duly licensed to operate satellite TV channels under the names of "BOL News" and "BOL Entertainment".
2. That Mr. Saleem Baig is working as Chairman Pakistan Electronic Media Regulatory Authority [PEMRA] and other proposed accused are also working in the same Authority at different posts.
3. That it is submitted the Complainant filed Writ Petitions before the Honorable Peshawar High Court challenging the appointment of Mr. Saleem Baig as Chairman PEMRA and other officials of the Authority on the ground that the said appointments are in violation of laws, rules and orders of the Honorable Supreme Court of Pakistan as well as Honorable High Court. However, after filing the above writ petitions, Mr. Saleem Baig and other officials of the Authority started coercive and unlawful drive against the Complainant and passed many unlawful decisions/orders against the Complainant which were assailed by the Complainant before the Honorable High Courts. It is pertinent to mention here that the Honorable Peshawar High Court in Writ Petition No.3937-P/2020 was pleased to pass an interim order dated 16-09-2020, whereby the Authority therein were restrained from taking any adverse action against the Complainant. The said interim order continues to operate till date.

However, on 03-02-2021, the Complainant has come into the knowledge that Mr. Saleem Baig has issued-illegal, unlawful and unjustified direction to the Cable operators through his regional heads and other official including proposed accused that to shut down the BOL TVs broadcast or shift the BOL channels to the last number.
5. The said act of the proposed accused is to an act of disobeying the law with intend to cause injury to the Complainant, thus liable to be punished under section 166 of the Pakistan Penal Code. The said act of the proposed accused also falls under Criminal Intimidation, hence the proposed accused are also liable to be punished under section 506 & 507 of Pakistan Penal Code.

In view of the above, you are requested to please register a FIR against Mr. Saleem Baig and others proposed accused under section 166, 503, 506 & 507, Pakistan Penal Code Pakistan Penal Code as well as all enabling laws which applicable under the given circumstances.
